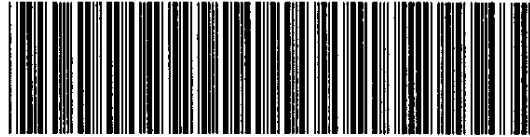

- Article I: The name of the organization shall be Girls in Focus Today, Inc. The period of duration is perpetual.
- Article II: The principal office is located at 323 St. Johns Avenue, Palatka, Florida which also serves as the mailing address.
- Article III: Girls In Focus Today, Inc is a non-profit corporation and shall operate exclusively for charitable purposes, within the meaning of the Section 501 c(3) of the Internal Revenue Code. The purpose is to focus on girls and young women in our community to be strong, confident and bold of character as they develop their future and our community.
- Article IV: Election of the Board of Directors will occur once a year at the Annual Corporation Board Meeting in December of each year by a majority vote of the current directors.
- Article V: Upon termination or dissolution of the Girls in Focus Today, Inc, any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501 c(3) of the Internal Revenue Code which organization(s) have a charitable purpose which, at least generally, includes a purpose similar to the purpose of Girls in Focus Today, Inc.
