ARTICLE III PURPOSE

The purpose for which the corporation is organized is: The objectives and purpose for which this Church Fellowship is constituted and this corporation organized are:

- 1. To disseminate the Gospel of Jesus Christ and the Word of God to the end that people of God may be confirmed to the image of Jesus Christ.
