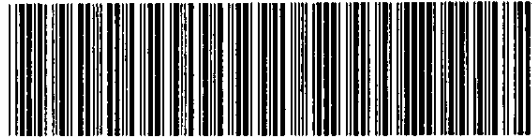

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I --- NAME.

The name of the corporation shall be:

ARTICLE II --- PRINCIPAL OFFICE.

ARTICLE III --- PURPOSE.

Trinity International Seminary and University, Inc. is exclusively organized for charitable, educational, religious, and scientific purposes, including for such purposes, the charitable operation of a university, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Trinity International Seminary and University, Inc. shall provide affordable, faith-based higher educational programs by utilizing distance learning tools, techniques, and technologies. Religious educational programs shall include bachelor's, master's, and doctorate degrees and certificates in the areas of, but not limited to, Pastoral Counseling; Christian Education; Evangelism; Faith-Based Business Management; and Religious Studies.

ARTICLE IV --- MANNER OF ELECTION.

The manner in which the directors are elected and appointed:

Initial directors are named in the Articles of Incorporation for the Trinity International Seminary and University, Inc. and initial directors shall hold an organizational meeting, at the call of a majority of the directors, to complete the organization of the corporation by appointing officers, adopting bylaws, and carrying on any other business brought before the meeting.

ARTICLE VIII --- PROHIBITION ON PRIVATE INUREMENT, POLITICKING AND

IMPROPER LOBBYING.

No part of the net earnings of Trinity International Seminary and University, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of Trinity International Seminary and University, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and Trinity International Seminary and University, Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, Trinity International Seminary and University, Inc. shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX --- DISSOLUTION CLAUSE.

Upon the dissolution of Trinity International Seminary and University, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Trinity International Seminary and University, Inc. is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X --- EFFECTIVE DATE.
