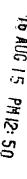

ARTICLES OF INCORPORATION FOR

ARTICLE ONE

The name for the corporation is THE VILLAGE OF LOVE COMMUNITY OUTREACH ING

ARTICLE TWO

ARTICLE THREE

The specific purpose for which this corporation is organized is:

To provide an environment that can be used as a resource center that provides counseling, job resources, tutoring services, positive life skills, family building, and fun activities in a one-stop setting. The objective of The Village Of Love Community Outreach Inc. is to keep juveniles as well as their parents engaged within the community through our mentorship program and provide resources that help to reduce the growing numbers of substance abuse, incarceration and broken family units. This program will also provide counselors with a Master degree in Mental Health Counseling who will serve as advocates and mediators for our participants. The Village Of Love Community Outreach Inc. will also serve as an outlet for single parent households as well as parents lacking time to attend to needs of their at risk child as well as themselves. The objective of need of the program in the community is to provide a tangible resource for Juveniles and their parents that instill a fun, healthy, role modeling environment where they can remain positively active within the community. Our main focus is to keep Juveniles away from negative environments and to help prevent them from engaging in at risk behaviors, while also encouraging and supporting the parents to believe that they are capable of maintaining healthy and positive family unity that will reduce the cyclical behavior of drug addiction and criminal activity, the site will be donated and operate on 56 acres with amenities that includes a gymnasium, an auditorium that seats 300 people, it has living quarters for males and females that sleeps a combine total of 220, a camp site, a lake for fishing, a cafeteria, and a classroom. During the week, the classroom would be used for academic tutoring, group counseling, and to teach life skills. The weekend would serve as a fun spot with limited overnight stay on a first come first serve bases by parents signing for overnight stay. Overnight stays would only be on Fridays after school, all day Saturday, and half days on Sunday during the school year. During the summer the organization will host a summer camp where juveniles can have fun and remain engaged throughout the summer in a positive environment. The overall objective is to reduce temptations that juveniles face when they are not engaged in the community keeping them from maladaptive behaviors within the community. This organization's funding will be provided through fundraisers, donations, grants and other support coming from the community. And will exercise suitable regulations and by-laws as may be appropriate for the establishment and maintenance of a sect of the charitable purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1985, as amended, or corresponding provisions of any

subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code, as may be amended from time to time. There will be no form of gambling such as bingo raffles or lotteries this corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

Each officer will be appointed by the President, termination of said Organization can only be done by a unanimous vote of the Executive Staff.
