**Article I: Name**

The name of the organization shall be the Edward W. Bok Academy Athletic Booster Club, Inc.

**Article II: Principal Office**

The principle street address for Edward W. Bok Academy Athletic Booster Club, Inc. is 13901 U.S. 27, Lake Wales, Florida 33859.

**Article III: Purpose**

The purpose of the organization shall be to encourage and support the athletic programs at Edward W. Bok Academy by providing financial assistance and lending moral support to the students, athletes, coaches, and teams. The organization shall support athletic and personal achievement in all student athletes, promote sportsmanship, and encourage parent and community involvement related to Bok Academy's athletic programs.

**Article IV: Manner of Election**

The officers of the organization shall include the President, Vice President, Secretary, and Treasurer. The election of officers shall take place during the General Membership Meeting at the beginning of each year. All Members of the organization may participate in the election. The Nominating Committee shall present a slate of officers for election. Further nominations may be received from the floor. The election of the slate, if non-contested, may be by voice vote. Any contested election shall be by written ballot. A majority of the votes cast by the Members shall be necessary for election. Should no person receive a majority of the votes cast, a run-off election between the two (2) persons who received the largest number of votes shall immediately be held. Any vacancies of officers because of death, resignation, or inability to serve, shall be filled by the Executive Committee for the remaining portion of the term. However, should a vacancy occur in the office of the President/Co-President, the Vice President shall immediately assume the office. Should a vacancy occur in the office of Vice President for any reason, the vacancy shall be filled by election at the next regular meeting of the membership, consistent with the procedures established in the By-Laws for the organization.

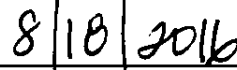
