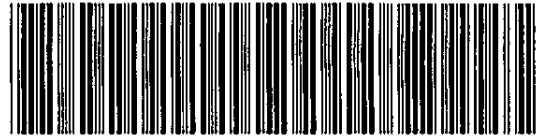

We are amending the "PURPOSE CLAUSE" of our not-for-profit organization to the following:

Achiever's Youth Learning Center Community Development Corporation is organized exclusively for charitable, religious, and educational purposes, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Our purposes also includes creating positive lifestyle projects for such purposes as building self-esteem, improving academic abilities while providing and restoring hope through "Faith Mentor-Ship Programs" to all challenged individuals who enter our organization.

We are also amending the "DISSOLUTION CLAUSE" of our not-for-profit organization to the following:

Upon the dissolution of Achiever's Youth Learning Community Development Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of our organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
