Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: It works with families, adults and adolescents who need assistance in developing the kind of everyday skills that allows them to function more securely, at home, school or work. We are experienced in working with a variety of behavioral modification therapies along with the Word of God, which has proven to be extremely successful.
