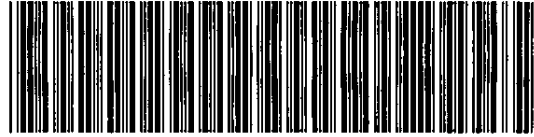

Purpose Clause:
