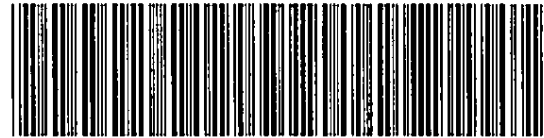

Article III- Purpose

Flagler Babe Ruth Baseball is a non-profit organization developed and maintained for the children and young adults, through the age of eighteen(18), of Flagler County.

We are committed to the development and refinement of their athletic skills, through positive competitive experiences, instruction and guidance.

Said organization is organized exclusively for charitable, religious, educational or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organization described under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Add to current Dissolution:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


