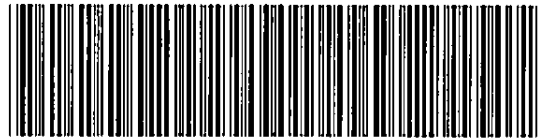

Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendment(s) to its Articles of Incorporation:

- (1) Article I – Name: Name of the Corporation shall be amended to:

- (2) Article III – Purposes: The Purpose of the Corporation shall be amended to:


