## **Exhibit A**

### **Article 3 Purposes**

- (a). To support the ordinances, doctrines and ethics established in the bible for the believer of our Lord Jesus Christ. To Nourish its members through a Christian, biblical education program. To direct tuition and offerings to the maintenance of the objects of the kingdom of the redeemer and to serve the community regardless of faith, race or creed.**
- (b). For the purpose of promoting, establishing, and administrating with a local Body of Believers (local church body), with all matters pertaining to fellowship, teaching, training and coaching in Market Place and Church related ministry. Membership with missionary outreach's religious seminars, officers and directors, Church government and operation to be determined and stated in By-Laws of the corporation hereinafter authorized b these Articles of Incorporation.**
- (c). To participate and conduct Christian outreaches, evangelism, training, fellowship, classes and coaching programs.**
- (d). Kemuel Christian University, Inc. shall be a wholly charitable organization.**
- (e). To acquire by conveyance or inheritance-whether by gift of purchase- real property, personal property and mixed real and personal property, to be received and held in trust for the use of and benefit of this corporation and its stated purpose.**
- (f). To improve, invest, sell, lease, assign, mortgage, or otherwise encumber any such property, when such an actions is deemed to be in the purposes of as Christian organization.**
- (g). To market audio and visual productions, books and gospels materials printed by said corporation for funding and furthering the gospel.**
- (h). To operate and manage Radio and T.V. outreach and stations.**
- (i). To solicit funds for each special project concerning the ministry on an organized giving plan.**



## **Exhibit B**

### **Article IV**

(a). The business affairs of Kemuel Christian University, Inc. shall be managed by and under the supervision of at least (3) Directors and or Trustees as set forth in the by-laws.

(b). Kemuel Christian University, Inc. shall have no less than (3) officers/directors at any-time who shall act as its Board of Directors. The number may be increased from time to time as set forth in the by-laws, but never less than three (3).

(c). Dr. Rolando Del Rio, Chairman of the board, shall serve indefinitely. If the chairman vacancy occurs a new chairman will be elected by the board members. The rest of the board of directors are elected on the annual business meeting, whenever a vacancy occurs. Whenever a vacancy occurs the election will be rescinded upon 2/3<sup>rd</sup> votes of the members of the Board Directors as set forth in the by-laws.
