Exhibit A

Article 3 Purposes

- (a) For the purpose of promoting, establishing, supervising and administering a Bible Coilege and Ministry training Center as well as a local Body of Believers (or local Bodies of Believes) with all matters pertaining to Church Worship and Fellowshipping, Church Membership, Missionary Outreaches, Religious Seminars, Church Officers, Church Government and church Operations and training of such, to be determined and stated in By-laws of the Corporation, hereinafter authorized by these Article of Incorporation. To support the ordinances, doctrines and ethics established in the bible for the believer of our Lord Jesus Christ. To Nourish its members through a Christian, biblical education program. To direct tuition and offerings to the maintenance of the objects of the kingdom of the redeemer and to serve the community regardless of faith, race or creed.
- (b) For the purpose of promoting, establishing, and administrating with a local Body of Believers (local church body), with all matters pertaining to fellowship, teaching, training and coaching in Market Place and Church related ministry. Membership with missionary outreach's religious seminars, officers and directors, Church government and operation to be determined and stated in By-Laws of the corporation hereinafter authorized b these Articles of Incorporation.
- (c) To participate and conduct Christian outreaches, evangelism, training, fellowship, classes and coaching programs.
- (d) Kemuel Christian University, Inc. shall be a wholly charitable organization.
- (e) To acquire by conveyance or inheritance-whether by gift of purchase- real property, personal property and mixed real and personal property, to be received and held in trust for the use of and benefit of this corporation and its stated purpose.
- (f) To improve, invest, sell, lease, assign, mortgage, or otherwise encumber any such property, when such an actions is deemed to be in the purposes of as Christian organization.
- (g) To market audio and visual productions, books and gospels materials printed by said corporation for funding and furthering the gospel.
- (h) To operate and manage Radio and T.V. outreach and stations.
- (i) To solicit funds for each special project concerning the ministry on an organized giving plan.
- (j) To participate in and aid organizations involved in Christian Outreach and Evangelism.
- (k) This corporation is wholly a Charitable Organization.

- (I) To License and Ordain qualified individuals for the gospel ministry, upon completion of required course programs.
- (m) To issue Degrees in Religious Studies upon the completion of all requirements from: Religious Associates to the Doctorate Degrees under the guidelines of Florida State Board of Independent Colleges Statue chapter 246-083

WHEREAS:

- We believe that, under God this group of believers has been called together for the finite tasks of maintaining in the city of Brandon, FL a testimony to the saving and keeping power of Jesus Christ.
- 2) We believe that God would be pleased with this body of believers, stand out in the community, as being independent of all outside organizational influences ecclesiastical or otherwise:
- 3) We believe that God will continually bless and expand the missionary activities and possibilities of this group of believers as promised in the Great Commission. *Lo I am with you always, even until the end of the age, "
- 4) We believe that it is our duty to work in harmony with, on a volunteer basis, other churches of "like precious faith" in carrying out the overall commission to the body of Christ.

THEREFORE, BE IT RESOLVED:

- 1) That we, by the Grace of God, do now assume the responsibility of carrying on a work of evangelism; of teaching the Word of God; of assembling ourselves together; of administering the ordinances of the church; and of all attending all means of grace, which our Lord has provided " for the perfection of the saints, for the work of the ministry, and for the edifying of the body of Christ:" Furthermore, in as much as God has called the church to a godly, in the present world, we should live soberly, righteously, and godly in this present world, (Titus 2:12) manifesting before the world our readiness for the coming again of our Lord and Savior.
- 2) That this body of believers shall, from this day forth, be known as KEMUEL CHRISTIAN UNIVERSITY, INC
- 3) What we do now adopt the following statement of Faith and of Doctrine, to which persons uniting with our fellowship must heartily agree.

1) If dissolution is required of the KEMUEL CHRISTIAN UNIVERSTY, INC. we will transfer all assets to another non-profit organization.
