

**The Articles of incorporation  
OUT OF MANY ONE IN JESUS CHRIST THE BELOVED INC.**

The undersigned acting as Founder an Incorporator of a Corporation pursuant to Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such Corporation on June 7<sup>th</sup> 2016, in Plantation Broward County, Florida.

**Article I**

The name of this Church shall be "OUT OF MANY ONE IN JESUS CHRIST THE BELOVED"

**Article II**

This Church is Located at 9816 NW 5<sup>th</sup> Court Plantation Fla. 33324, the mailing Address is the same as the above.

**Article III**

The purposes for which the corporation is organized are:

1. To preach the gospel of our lord Jesus Christ according to the interpretation given in the By- Laws of this Corporation.
2. To incorporate other churches to our Corporation, included but not limited to missions
3. To Ordain Ministers

**Article IV**

The duration the congregation is to continue shall be perpetual unless dissolved only by the president.

**Article V**
