## Articles of Incorporation of Forza Stefano Charitable Foundation, Inc. In compliance with Chapter 617, F.S. (Not for Profit)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Not for Profit Organization under the Florida Not For Profit Corporation Act, do hereby certify:

First: The name of the Organization shall be FORZA STEFANO CHARITABLE FOUNDATION, INC.

**Second**: The place in this state where the principal office and mailing address of the Organization is to be located is 14248 N.W. 19<sup>th</sup> St., Pembroke Pines, FL 33028 or any other place designated from time to time by the Board of Directors of the Organization.

Third: The Organization is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 50l(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code. In accordance therewith, the purpose for which the Organization is organized is to assist athlete children who have been subject to a major health condition or treatment and foster their participation in national or international amateur sport events and competitions, to assist the family members of sick amateur athletes to cope with the daily events of life, and to support the educational advancement and training of qualified candidates that wish to practice a sport while attending school or college. Notwithstanding any other provision of these articles, this Organization shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Organization.

Fourth: The Organization shall have as members those persons who subscribe this Articles of Incorporation and those other members who are admitted by the Board of Directors, who agree to be bound by these Articles of Incorporation and by the bylaws and policies set forth by this Organization, and who actively participate in the development of its mission.

Fifth: The Organization shall have a board of directors of at least five (5) members, out of which one shall be named as President of the Organization and shall chair the meetings of the boarder

directors, another director shall serve as the Vice President of the Organization, another director shall be the Treasurer and another director shall be the Secretary.

**Sixth:** The manner in which the directors of the Organization are elected and appointed shall be stated in the bylaws of the Organization.

No substantial part of the activities of the Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Organization shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(J) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section I 70(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Eleventh: Upon the dissolution of the Organization, the assets shall be distributed for one or more

exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the

corresponding section of any future federal tax code, or shall be distributed to the federal

government, or to a state or local government, for a public purpose. Any such assets not so

disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the

principal office of the Organization is then located, exclusively for such purposes or to such

organization or organizations, as said Court shall determine, which are organized and operated

exclusively for such purposes.
