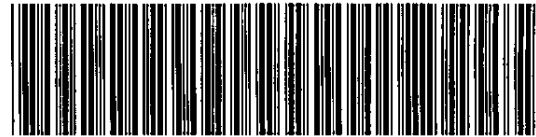

**ARTICLES OF INCORPORATION  
OF  
KUKUA INSTITUTE, INC.**

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as an incorporate in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit corporation.

**ARTICLE I  
NAME**

The name of this corporation is Kukua Institute, Inc.

**ARTICLE II  
DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III  
PURPOSE**

The Corporation is organized exclusively for charitable, scientific, educational, and research purposes, including for such purpose, the making of distributions to organizations that qualify as exempt Organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, and Section 617.0301 of the Florida Not For Profit Corporation Act (the "Act"), as now in effect or as may hereafter be amended. Such purposes include but are not limited to celebrating, empowering and including African Americans and others in cultural and social programs, community events, educational and research opportunities, and community and economic development.

**Section One: KUKUA INSTITUTE, INC.**

In furtherance thereof, the Corporation may receive property by gift, devise or bequest, invest or reinvest the same, and apply the donations and principal thereof, as the Board of Directors may from time to time determine, either directly or through contributions to any charitable organization or organizations, exclusively for charitable, scientific, education and research purposes.

In furtherance of its corporate purposes, the Corporation shall have all the general powers enumerated in Section 617.0302 of the Act, together with the power to solicit grants and contributions for such purposes.

**ARTICLE IV  
MANNER OF ELECTION**

The initial Board of Directors shall be comprised of the Directors named in Article V of these Articles of Incorporation. This number may be increased or decreased from time to time in accordance with the Corporation's Bylaws, but shall never be less than three (3). New directors shall be elected at next annual meeting of the Board and each director shall hold office until the director's successor has been qualified and elected, or until the director's death, earlier resignation or removal from office by majority vote of the Board.

The directors of this Corporation may take action by written consent as provided by law.


**ARTICLE XII


