ARTICLES OF INCORPORATION OF DEER PARK COTTAGES HOMEOWNERS ASSOCIATION, INC.

ARTICLE I. NAME

The name of this corporation shall be DEER PARK COTTAGES HOMEOWNERS ASSOCIATION, INC., with its principal office address being located at 5445 W. Oak Park Blvd., Homosassa, Florida 34446.

ARTICLE II. DURATION

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE

DEER PARK, LLC., as developers of certain real property located in Citrus County, Florida known as Deer Park as provided on the Plat thereof recorded in Plat Book 19, Page 111-112, as amended, have filed in the Public Records of Citrus County, Florida, a Declaration of Covenants, Conditions, Restrictions and Easements, ("Declaration"), pertaining to the subdivision, and may in the future impose other restrictions and conditions upon the land in Deer Park. This corporation is being formed for the purpose of carrying out the duties and responsibilities of the Declaration within Deer Park through the Declaration recorded in O.R. Book 2760, Page 2012, as amended, Public Records of Citrus County, Florida, and to perform such other duties, to promote the general well being of and harmony among the property owners within Deer Park and the common areas within Deer Park subdivision.

ARTICLE IV. DEFINITIONS

The capitalized words and terms used in these Articles shall have the meaning described within the Declaration, as such may be amended from time to time.

ARTICLE V. POWERS

This Corporation shall have all of the common-law and statutory powers granted to not-for-profit corporations, and it shall have the power and the authority to carry out the duties and responsibilities of the Declaration and such other and further powers in the best interests of the property and property owners within Deer Park and the common areas within Deer Park. In addition to these powers and without limiting the generality of the above the corporation shall have the following specific powers:

- a. The power to own and convey property;
- b. The power to operate and maintain the surface water management facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention area, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas;
- c. The power to establish rules and regulations;
- d. The power to assess members and enforce asse



- e. The power to sue and be sued;
- f. The power to contact for services to provide for operation and maintenance of the surface water management system facilities if the corporation contemplates employing a maintenance company;
- g. The power to require all homeowners, lot owners, property owners or unit owners within Deer Park to be members of the corporation; and,
- h. Take any other action necessary for the purposes for which the corporation is organized.

ARTICLE VI. SURFACE WATER MANAGEMENT SYSTEM; DISSOLUTION

If this corporation is ever dissolved, the property consisting of the surface water management system shall be conveyed to an appropriate agency of local government, and that if not accepted, the surface water management system shall be dedicated to a similar non-profit corporation.

ARTICLE VII. MEMBERS

Every fee simple owner of a Lot within Deer Park shall be a member of this Corporation.

ARTICLE VIII. DIRECTORS

The affairs of the Association will be managed by a Board of Directors consisting of the number of directors as provided in the Bylaws. The method of election of directors is as stated in the corporate Bylaws

ARTICLE IX. OFFICERS

The affairs of the corporation shall be administered by such Officers as are provided within the Bylaws.

ARTICLE X. INDEMNIFICATION

Every Director and every Officer of the corporation shall be indemnified, saved and held harmless by the corporation against all expenses and liabilities, including attorney's fees, reasonably incurred by the Director or Officer, to which the Director or Officer may be a party, or in which the Director or Officer may become involved by reason of the Director or Officer being or having been a Director or Officer of the Corporation, whether or not the Director or Officer is a Director or Officer at the time such expenses are incurred, except when the Director or Officer is adjudged guilty or willful misfeasance of malfeasance in the performance of the Director's or Officer's duties; provided that in the event of a settlement the indemnification shall apply only when the Board of Directors approves such settlement and reimbursement as being in the best interest of the corporation. The foregoing right of indemnification shall be in addition to and not operate to the exclusion of any and all other rights to which the Director or Officer may be entitled.

ARTICLE XI. BYLAWS

The first Bylaws of the Association shall be adopted by the Board of Directors and may be altered or amended as provided by the Bylaws.

ARTICLE XII. AMENDMENTS

The Articles may be amended upon the affirmative vote of not less than 75% of the members of the corporation.

ARTICLE XIII. EFFECTIVE DATE

Effective as of the date of this filing.
