

#### ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

#### **ARTICLE I - NAME**

The name of the corporation shall be WISDOM INTERNATIONAL NETWORK MINISTRIES-LIBERTY CHAPEL INTERNATIONAL, INC.

#### ARTICLE II - PRINCIPAL OFFICE

The Principal street address and mailing address is 4632 Calendula Drive, Orlando, Florida 32839.

#### ARTICLE III - PURPOSE

The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The purposes for which said corporation is formed and being recognized and exclusively religious, public worship, and charitable/benevolent are as follows: to wit:-

- a. To maintain a place of religious worship, to conduct regular and/or evangelistic meeting, religious services; divine worship or other religious observances with the intent of perpetuation of the Gospel of Jesus and Jesus love to the whole world and every creature.
- b. To propagate the whole Gospel Message of Salvation, deliverance from all sin and unrighteousness through the blood of Jesus Christ by repentance from sin, water baptism by immersion in the name of the Lord Jesus Christ for the remission of sins, receiving the baptism of the Holy Spirit and the continuance of a godly life;
- c. To establish and maintain a Bible School and publications, teaching the

fundamentals of the Bible to all ages;

- d. To visit hospitals, nursing homes shelters, prisons, and other institutions;
- e. To organize missionary work both nationally and internationally, by feeding and clothing the poor, providing adequate shelter for the homeless, medical care for the needy, and by embarking upon community development projects;
- f. To promote the Holy Word of God through the teaching of the Bible;
- g. To ordain Bishops, Elders, Ministers, Evangelists, Deacons, Missionaries, and other officers according to the ordinances of the church;
- h. To teach, counsel, instruct youths in religious matters and encourage youth activities:
- i. To perform rituals such as marriages according to the laws of the State of Florida and to conduct communion, baby dedications, baptisms and funerals as per request in accordance with the church's ordinances, and to perform every lawful church function.
- j. To establish, maintain and operated Day Care Centers, Orphanages, Homes for the Elderly, upon compliance with applicable statutes and all other facilities necessary to uplift and meet the needs of the community;
- k. To broadcast religious services through the medium of radio, television, seminars, workshops, conferences and in any manner possible in order spread the Gospel of Jesus Christ and to win souls for Jesus Christ;
- 1. To promote brotherly love to all mankind;
- m. To have the power to solicit and raise funds by any and all proper and appropriate means, under and subject to the Not for Profit Corporation Law, and to receive and disburse such funds or money accruing from tithes, offerings, collections or any other contribution for the general support of said corporation;
- n. To do everything and anything reasonably and lawfully necessary, proper, suitable or convenient to achieve any or all of the objectives and purposes set forth in this Articles of Incorporation; and
- o. To do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof but not the pecuniary profit or financial gain of its members and trustees, except as permitted under the Not for Profit Corporation Law.

#### ARTICLE IV – MANNER OF ELECTION

The manner in which the directors are elected and appointed is provided in the Bylaws of the corporation.

#### **ARTICLE VI – LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political

campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on

any other activities not permitted to be carried on (a) by an organization exempt from federal

income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of

any future federal tax code, or (b) by an organization, contributions to which are deductible

under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future

federal tax code.

ARTICLE VII – DEDICATION OF ASSETS

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes

within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section

of any future federal tax code, or shall be distributed to the federal government, or to a state or

local government, for a public purpose. Any such assets not so disposed of shall be disposed of

by a Court of Competent Jurisdiction of the county in which the principal office of the

corporation is then located, exclusively for such purposes or to such organization or

organizations, as said Court shall determine, which are organized and operated exclusively for

such purposes.
