Articles of Incorporation Of

Article 1.

The name of the corporation is Power Alley Performance Center, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 8100 Park Blvd, Pinellas Park, FL 33781. The initial registered agent of the Corporation at such address shall be: Joseph Sullivan.

Article 3.
