

**SHALOM CENTER OF EXCELLENCE, INC.**

ARTICLE III

PURPOSE

The Corporation is not formed for pecuniary profit or financial gain. The Corporation shall be a not for profit corporation under the Florida Not For Profit Corporation Act and is irrevocably dedicated to and operated exclusively for non-profit purposes. The purposes for which the corporation is organized are exclusively education within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or any successor thereto). Furthermore, the purposes for which the Corporation is organized are to own a "charter school" within the meaning of Florida Statutes Section 228.056 (or any successor provision) which shall operate as a school for grades kindergarten through twelve for the purpose of providing a safe environment that allows individuals on the autism spectrum the ability to reach their potential and facilitate the development of essential life skills needed towards independency. Such charter school shall comply with all laws applicable to "charter schools" including without limitation Florida Statutes Section 228.056(8) (or any successor provision).

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by corporations exempt from federal income tax under Section 501(c)(3) of the Internal Revenue code of 1986, as amended (or any successor thereto) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal revenue Code of 1986, as amended (or any successor thereto).




