2205 NW 107th ST, Miami, FL 33167. The corporation is organized pursuant to the State of Florida,
non-profit Corporation code.
- Two: This Corporation is a non-profit public benefit corporation and is not organized for the private gain of
any person. The corporation is organized under the non-profit public benefit corporation law for charitable
and educational purposes. The program (s) will consist of but shall not be limited to: Alternative
Living Facility; After- school program (s) for youth at high risk; Counseling; Housing; Job
training and Job placement; Substance Abuse; and other programs to aid those at risk.
- Three: The duration of this corporation shall be perpetual, shall have no stock and shall have no members.
