## SECOND AMEDMENT TO THE ARTICLES OF INCORPORATION By Planet Swim Aquatics, Inc.

Pursuant to the provisions of section 617.1002 and 617.1006, Florida Statutes, the undersigned Florida not for profit corporation ("Corporation") adopts the following articles of amendment to its articles of incorporation.

#### MANNER OF ADOPTION

This second amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.

These Articles of Amendment were adopted by the board of directors of said Corporation at a regular meeting with a quorum being present which was held on August 17, 2018.

#### THE AMENDMENTS

The Articles of Incorporation of the Corporation are hereby amended as follows:

1. Article III of the Articles of Incorporation is hereby replaced. The new Article III reads in its entirety as follows:

ARTICLE III. PURPOSE

Planet Swim Aquatics Association is a parents' support organization of Planet Swim' competitive swim team. The exclusive purpose of this Corporation is to engage in charitable, educational, religious, or scientific activities, including, for such purpose, the making of distributions to organizations that qualify as exempt under section 501(a) of Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue law.

The primary function of Planet Swim Aquatics Association is to support the development of amateur athletes to participate in National and International competition by hosting competition and clinics to provide assistance with travel meet related expenses; social team activities and team gear to all members of Planet Swim competitive swim team. The majority of Planet Swim Aquatics Association funding will come from the general public, corporations, or other public charities.
