ARTICLE III PURPOSE

The purpose for which the corporation is organized is: ___TO GIVE AFFIMATION TO WOMEN AND MEN, BOYS AND GIRLS, IN BECOMING THE VOICE OF THE UNHEARD, TO BECOME THE VOICE OF THE FORGOTTEN, THE SILENT, THE LOST, THE HURTING, THE REJECTED AND MISUNDERSTOOD-

1. Purpose
