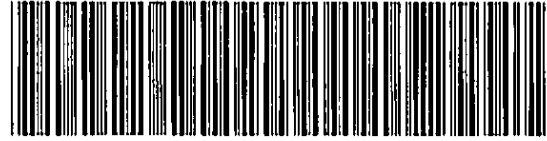

Amend existing article:

ARTICLE III: PURPOSE

The purpose (objective) of the Corporation is 1. Providing education concerning the art and science of digital photography, 2. Assisting charitable organizations and individuals in the conduct of their photographic activities, 3. Assisting local charitable organizations to access no cost event photographers, 4. Promote collective photographic learning and knowledge exchange in a general setting and within special interest groups. 5. Organizing photographic exhibitions, events, competitions, judging, and analysis, 6. Providing instruction in the use of camera equipment and in photographic techniques.

Add additional article:

ARTICLE IX: DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of the corporation, all debt shall be paid and any remaining funds in the treasury shall be distributed to a charity or scholarship at the discretion of the Executive Board. All appropriate entities and governmental authorities shall be informed thirty (30) days prior to the date of disbandment.
