

The undersigned subscribers to this charter, each being of legal age, competent to HASSEE. FLORIDA contract, hereby associate themselves together to form a corporation not for profit under the Laws of the State of Florida.

ARTICLE I: The name of this corporation shall be Dundee Lodge No. 2711, Loyal Order of Moose, Inc. and the principal place of business shall be 142 Winona Circle, Auburndale, FL 33823 County of Polk, in Florida.
