

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation on March 11, 2017 there are no members entitled to vote. The board of directors adopted these amendments by a vote sufficient for approval.

**ARTICLE III**

The purpose for which the corporation is organized is to raise money for patients suffering from brain tumors and/or other related debilitating medical conditions. Anyone in the community can apply for funds to assist with medical costs. Applicants with medical needs will be eligible to receive assistance as long as they apply and are able to prove that the need exists in order to receive funds to pay for treatment, procedures, and/or surgeries that are not covered by traditional medical insurance.
