## ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S. (Not for Profit)

KNOW ALL MEN BY THESE PRESENTS:

We, being natural persons of the age of 21 years or more, and members of the Spiritual Assembly of the Bahais of Tamarac, Broward County, Florida, an unincorporated association, being duly authorized and empowered by a resolution passed and adopted by the Bahai community of Tamarac, Broward County, FL for the purpose of forming a not-for-profit corporation under and in accordance with the State of Florida, DO HEREBY CERTIFY:

### Article I. NAME OF CORPORATION

The name of the corporation is SPIRITUAL ASSEMBLY OF THE BAHAIS OF TAMARAC, INC.

### Article II. PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of the Corporation shall be:

8405 NW 58<sup>th</sup> Place, Tamarac, FL 33321

### Article III. PURPOSE OF CORPORATION

The purpose of the Corporation is exclusively for religious and charitable purposes, including for such purposes, including for such purposes the making and distributions to organization that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code") or the corresponding provision of any future United States Internal Revenue Law.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, trustees, incorporators or any other private persons, except that the corporation shall be allowed to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a

corporation exempt from Federal income tax under Section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code Code (or the corresponding provision of any future United States Internal Revenue Law)

The corporation is organized for the establishment and maintenance of religious worship and spiritual activities in Tamarac, Broward County, Florida in accordance with the principles of the Bahai Faith as set forth by Bahauallah, its Founder; Abdul-Baha, its Interpreter and Exemplar, Shoghi Efendi, its Guardian; the Universal House of Justice, its supreme legislative body, and the National Spiritual Assembly of the Bahais of the United States of America; and further for the doing of any and all things necessary and incident to the performance of the purposes set forth above insofar as the same are permissible under Florida law.

#### Article IV. BOARD OF DIRECTORS; APPOINTMENT AND ELECTION

The first Board of Directors shall be nine in number, their names and addresses being as follows:

The duration of the corporation shall be perpetual.


Article VIII. AMENDMENTS

The Articles of Incorporation may be amended from time to time.


ARTICLE VIII. DISSOLUTION

Upon dissolution of the Corporation, liquidation or abandonment of its property, assets remaining after the payment of, or provision for payment of, all liabilities of the corporation, shall be disbursed to the National Spiritual Assembly of the Bahais of the United States if then in existence and except under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law), otherwise to an organization or organizations, organized and operated exclusively for religious, charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law),
