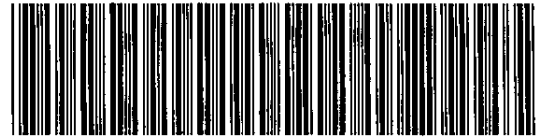

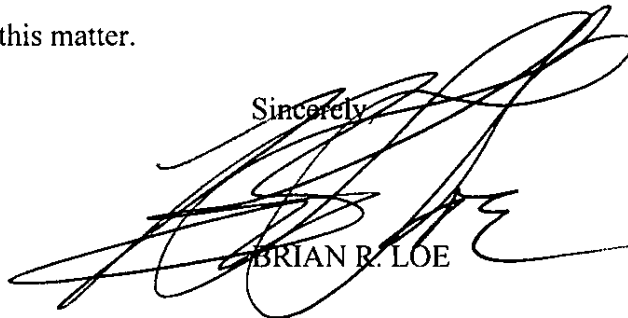

In compliance with the requirements of F.S. Chapter 617, the undersigned, ERNEST MANDER, hereby sets forth the following Original Articles of Incorporation of **WEDNESDAY WASH DAY, INC**:

ARTICLE I

The name of the Corporation is **WEDNESDAY WASH DAY, INC.**

ARTICLE II

The street address of the initial principal office of the corporation is located at 700 Rinehart Road, Lake Mary FL 32746. The initial mailing address of the Corporation is also 700 Rinehart Road, Lake Mary FL 32746.

ARTICLE III

The purpose for which the corporation is organized is to provide eleemosynary and charitable care to the homeless, the indigent, the widowed, the orphaned, the lonely any in true spiritual need who from time to time will be resident in some way in Central Florida, including but not limited to the raising and administration of funds for that purpose, for the provision of laundry services, food, medical care, clothing, dental care and veterinary care for their animals; for education and training for them that they may become independent and productive, and any and all related services to the purpose of this corporation.

The manner in which the directors are elected appointed is: Annual election by a majority of the board of directors.

ARTICLE VI

Upon Dissolution the assets of this corporation may not, cannot and will not be distributed to the members of this corporation. Upon dissolution the assets of this corporation may only be distributed to one or more exempt purposes as set forth in Section 501(c) of the Internal Revenue Code.

ARTICLE VII

This corporation is expressly prohibited from engaging in any activity for the purpose of propagandizing or otherwise attempting to influence legislation, nor, shall it ever act on behalf of, or in opposition to, any candidate for public office.

ARTICLE VIII

The assets of this corporation are intended to be devoted to pursuit of the purposes of this corporation and the powers set forth herein are limited to any and all acts necessary to engage in the purposes of ARTICLE III, as amended above.

ARTICLE IX

At no time may the board of directors or the shareholders of this corporation authorize the corporation to make substantial diversion of corporate income or assets whether by preferential loan, excessive payment, over-compensation or preferential sales or purchases of property, to the incorporator or the incorporators family members, or to a substantial contributor or such contributors family or, to the owner of a 50 percent or greater voting power in the corporations affairs.

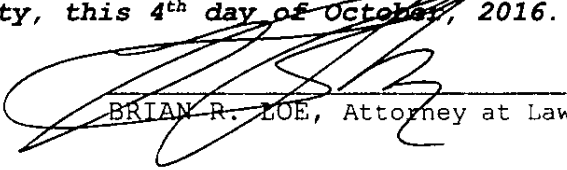
