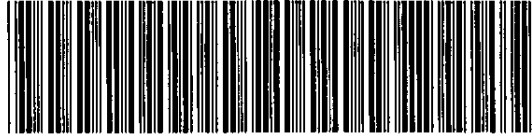

ARTICLES OF INCORPORATION

PREAMBLE

In compliance with the Florida Not for Profit Corporations Act, Florida Statutes Chapter 617, the undersigned citizens of the United States desire to form a not for profit corporation and hereby certify the following:

ARTICLE I. NAME

The name of the corporation shall be Jesus GIH Ministry, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal office of the corporation is located at 5318 34th Street East, Bradenton, FL 34203.

ARTICLE III. PURPOSE

The corporation is organized exclusively for charitable, educational, and religious purposes within the meaning of Internal Revenue Code Section 501(c)(3), including the making of distributions to organizations that qualify as exempt organizations under Internal Revenue Code, Section 501(c)(3).

ARTICLE IV. MANNER OF ELECTION

The manner of election of the directors of the corporation shall be provided by the corporate bylaws.

ARTICLE V. POWERS

The powers of the corporation shall be provided by the corporate bylaws in compliance with the Florida Not for Profit Corporations Act, Florida Statutes Chapter 617, and with the following limitations within the meaning of Internal Revenue Code Section 501(c)(3):

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office, including the publishing or distribution of statements.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes set forth in these articles.

ARTICLE VI. DISSOLUTION

The assets of the corporation shall be permanently dedicated to exempt purposes. Upon the dissolution of the corporation, the assets shall be distributed for exempt purposes within the meaning of Internal Revenue Code Section 501(c)(3), or shall be distributed to a state or federal government for a public purpose. Any assets not so distributed shall be distributed by a court of

competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such exempt purposes or to such organizations which are organized and operated exclusively for such exempt purposes.
