In Compliance with Chapter 617, Florida Statutes (Not for Profit)

### Article I - Name

## Article III - Purpose

- 1. Newcomers of the Beaches, Inc., is organized exclusively as a social club within the meaning of section 501(c)(7) of the Internal Revenue Code, or the corresponding section of any future recertain tax code.

### Article VI - Limitations

No part of the net earnings of the corporation may inure to the benefit of, or be distributable to its members, directors or officers, or other private persons, except that the corporation shall be authorized

and empowered to pay reasonable compensation for services rendered and to make payments and sistributions in furtherance of the purposes set forth in Article III hereof.

Notwithstanding any other provision of these articles, the corporation shall not carry out any activities not permitted to be carried out by a corporation exempt from federal income tax under section 501(c)(7) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

# Article VII - Dispensation of Assets Upon Dissolution

Upon the dissolution, termination or winding up of the corporation, assets shall be distributed to an organization exempt from federal taxation under section 501(c)(7) of the Internal Revenue Code with a purpose similar to that of the corporation, or for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
