ARTICLE I: NAME

ARTICLE II: PRINCIPAL OFFICE

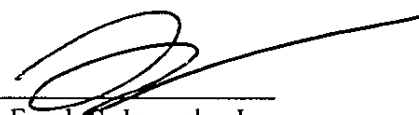
The street address and mailing address of the principal office of the corporation is: 379 Whitcomb Drive, Geneva, FL 32732.
