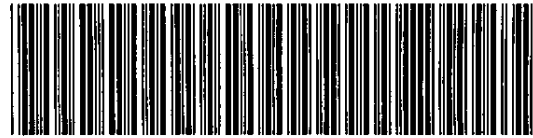

ARTICLE I - NAME

The name of the corporation shall be Lake County Hispanic American Association, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal office of the corporation is 665 E. Highway 50, Clermont, Florida 34711.

The mailing address of the corporation is 614 E. Highway 50, P.O. Box 152, Clermont, Florida 34711.

ARTICLE III - PURPOSE

The corporation is organized exclusively for charitable, religious, educational, and/or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation shall have the power to provide scholarships and mentoring while maintaining our Hispanic American culture in the service of the youth of Lake County; to provide education; to accept gifts and donations of money and property, real or personal, for the above-stated purposes of the corporation; to provide a staff and to provide compensation for those engaged in the above-stated purposes as an endeavor for the public benefit of the community. The corporation shall also have such power and authority as are allowed and granted to not-for-profit corporations under the laws of the State of Florida and those of the United States of America.

ARTICLE IV - POWERS AND LIMITATIONS

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

In compliance with Chapter 617, F.S., (Not-for-Profit)

ARTICLE V - DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or any other corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s), as said Court shall determine to be organized and operated exclusively for the above-stated purposes of this corporation.

ARTICLE VI - TERM OF EXISTENCE

The corporation shall have perpetual existence unless sooner terminated by not less than three-fourths vote of the entire Board of Directors.

ARTICLE VII - MANAGEMENT OF CORPORATION

The affairs of the corporation are to be managed by a Board of Directors and all matters pertaining to the election or appointment of directors, including the number of directors and the duration of the term of office for each director, shall be governed in accordance with the provisions of the Bylaws of the corporation.

ARTICLE VIII - REGISTERED AGENT

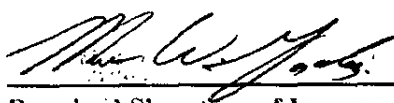
