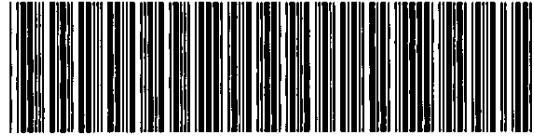

government, for a public purposes.


