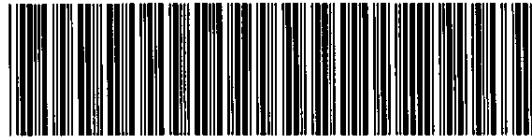

## **ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S. (not for profit)

### **ARTICLE I - Name**

The name of this corporation shall be LET ME PLAY FOUNDATION, INC.

### **ARTICLE II - Principal Office**

The principal street address is 14561 Cablesire Way, Orlando, Florida, 32824.

### **ARTICLE III - Purpose**

The purpose for which the corporation is organized is to help youth in education and sports.

The corporation is organized exclusively for charitable purpose, including, for such purposes, to bring life changing values, through sports, to every child, regardless of income or geographic location; to create a positive, safe, and value-oriented atmosphere in which participants learn teamwork, sportsmanship and interactive skills; to develop a soccer program to give opportunity for children with physical and/or mental disabilities.

### **ARTICLE IV – Manner of Election**

The manner in which the directors are elected and appointed:  
Directors shall be elected annually, at the annual meeting of members of the Board of Directors, by a plurality of the votes cast by the incumbent members of the Board of Directors.

### **ARTICLE V – Initial Officers and/or Directors**

### **ARTICLE VI - Bylaws**

The members of the Corporation shall have the right to make and adopt such bylaws as they shall deem proper and advisable, and they may be amended, altered or repealed by the Corporation members in accordance with the provisions in the Corporation Bylaws, as adopted.

## **ARTICLE VII - Duration**

This corporation shall have perpetual existence.

## **ARTICLE VIII - Amendments to Articles of Incorporation**

The articles of Incorporation may be amended, altered, changed or repealed in the manner now or hereafter prescribed by the Statutes of the State of Florida, and in accordance with the Bylaws of the Corporation, and all rights conferred upon officers, directors and members herein granted are subject to this reservation.

## **ARTICLE IX - Membership**

Those persons and entities accepted for membership in the LET ME PLAY FOUNDATION, INC. shall subscribe to the Bylaws of this Foundation.

## **ARTICLE X - General Provisions**

This Corporation shall have all the powers and rights conferred upon it by Statute, including but not limited to, the following: to receive, take, hold, lease, buy, sell, mortgage and convey real estate and personal property; to enter into, make and perform contracts of every kind; and to make, accept, endorse, and issue promissory notes, and other negotiable or transferable instruments and evidences of indebtedness, whether secured by mortgage or otherwise, and as permitted by the Bylaws of the Corporation.

## **ARTICLE XI - Dissolution**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed or shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.






