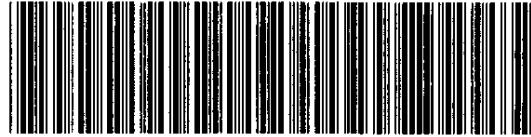

ARTICLE IX DISSOLUTION

Upon the dissolution of the Corporation, the directors shall, after paying or making provisions for the payment of all the liabilities of the Corporation, dispose of all the assets of the Corporation exclusively for the purposes of the Corporation in such manner or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of a successor law thereto), as the directors shall determine. Any such assets not so disposed of shall be disposed of by the court having jurisdiction thereof in the county in which the principal office of the Corporation is then located, exclusively for such purposes as such court shall determine most closely corresponds to the activities and purposes carried out by the Corporation and which qualify under the above
