# Articles of Incorporation of SKI FOUNDATION CCAFS INC.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: SKY LIMITS INC has several businesses under its umbrella. We at SKY LIMITS INC would like to provide help to the community and specifically young male youth. To give them a strong foundation to begin life. Which includes financial literacy, health education, and develop skills to leave a positive impact on their perspective community.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.
