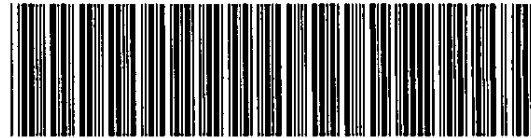

This Corporation shall not participate in or support any political party, political activity, or political candidate.

In its membership and other relationships, Mt. Canaan Missionary Baptist Church, Inc. will not discriminate on the basis of race, ethnicity, or national origin. All who are a part of this body may receive the Word of God and the teachings of the Lord Jesus Christ and participate in the life of this Church; and such participation shall not disrupt the harmony of congregational life and substantially held religious beliefs.

In the event that this Church shall ever cease to exist, upon dissolution, liquidation and winding-up of the Corporation, the officers shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation to the Second Bethlehem Baptist Association or the Florida General Baptist Convention, Incorporated, organizations operated exclusively for charitable, educational, and religious purposes, and as shall at the time qualify as an exempt organization under Section 501 (C) or 501 (C) (3) of the Internal Revenue Code of 1954 as amended, as the officers may determine.
