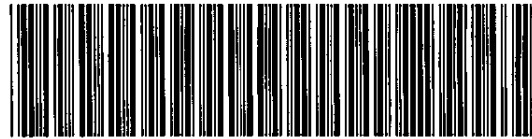

## **ARTICLES OF INCORPORATION FOR**

### **SISTER 2 SISTER MINISTRIES, INC**

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

#### **ARTICLE I-NAME**

The name of the corporation shall be: **SISTER 2 SISTER MINISTRIES, INC**

#### **ARTICLE II-PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

#### **ARTICLE III-PURPOSE**

The corporation is organized exclusively to promote spiritual awareness and provide a ministry for women of all ages and from all walks of life. A forum that seeks to help and offer women an arena for encouragement, practical teaching, support, inspiration, help and to improve the quality of life for themselves and their families. We will make distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future Federal Tax Code. We will use the methods below to accomplish the afore mentioned objectives:

- Workshops
- Prayer and Bible Study
- Seminars and Practical Experience to Educate
- Mentorship Programs which will foster involvement in their local churches and communities.

#### **ARTICLE IV-MANNER OF ELECTION**

The manner in which the directors are elected or appointed by a forum of twelve (12) board members with each member casting one (1) vote. The management of the corporation shall be at all times under the direction of the Executive Director. The operation of the corporation shall be defined by its Bylaws. The directors and the other members of the committee shall constitute a quorum of that meeting each third Thursday of each month and third Saturday of the quarter. Vacancies in the Executive Board shall be filled by a vote of the majority of the remaining members of the Board. At no time shall the board be less than twelve (12) members. The Secretary shall be appointed by the Executive Board and serve a term of no less than three (3) years. Each Board member shall have one vote and proxy may not do such voting.

## **ARTICLE V-POWERS**

The corporation shall have all the powers set forth in Florida Statue 617.0302 unless specifically prohibited by these Articles of Incorporation.

Notwithstanding any other provision of these articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

## **ARTICLE VI - DISTRIBUTION OF ASSETS**

In the event of dissolution of the corporation, the assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code of shall be distributed to the Federal, State or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the court of competent jurisdiction, of the county in which the principal office of the corporation is then located exclusively for such purpose.
