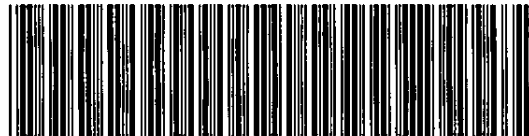

ARTICLE I NAME

The name of the corporation shall be the Type Zero Foundation Inc

ARTICLE II PRINCIPAL OFFICE

Principal street address and mailing address of the Corporation shall be 2560 Bullion Loop, Sanford FL., 32771.

ARTICLE III PURPOSE

This Corporation does not contemplate pecuniary gain or profit to its members. The purpose for which the corporation is organized is exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or under any corresponding provisions of any subsequent federal tax laws governing the distributions to organizations qualified as tax-exempt. The goal is to promote health awareness and physical activity to the people of Central Florida in an effort to educate and prevent diabetes. The art of dance will be utilized in achieving this goal. Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not for profit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

The affairs of this Corporation shall be managed by its Board of Directors. An annual board of directors meeting shall be held in which directors will be elected and appointed through the dictation of the votes of the majority.






