CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF ESPLANADE ON PALMER RANCH HOMEOWNERS ASSOCIATION, INC.

(A Florida corporation not for profit)

Pursuant to Chapter 617,1006 of the Florida Not For Profit Corporation Act

CHRISTOPHER G. LONG, Secretary of ESPLANADE ON PALMER RANCH HOMEOWNERS ASSOCIATION, INC., a Florida corporation not for profit ("Association"), does hereby certify under the seal of the Association as follows:

- The Association was originally incorporated on October 28, 2016, Document Number N16000010539, under Chapter 617 of the laws of the State of Florida.
- The Declaration of Covenants, Conditions, Restrictions and Easements for Esplanade on Palmer Ranch was recorded on December 16, 2016, as Instrument # 2016155390, of the Public Records of Sarasota County, Florida.
- Article XIII, Section B, of the Articles provides that after the First Conveyance and prior to the Turnover Date the Articles may be amended solely by a majority vote of the Board, without the prior written consent of the Memhers, at a duly called meeting of the Board.
- The Board of Directors of the Association is desirous of amending the Articles to increase the number of directors and to provide for staggered terms.
- The following Amendment was adopted by the Board of Directors by Written Consent in Lieu of Meeting on December 15, 2017, and there are no members entitled to vote on the Amendment

NOW, THEREFORE, the Articles are hereby amended as follows:

- Article X, Section A, is hereby amended to read as follows:
 - The number of Directors on the first Board of Directors of the Association ("First Board") and the "Initial Elected Roard" (as hereinafter defined) shall be no less than three (3), and no more than five (5) as determined by Declarant. The number of Directors elected by the Members subsequent to the "Declarant's Resignation Event" (as bereinafter defined) shall be an odd number of no less than three (3) and no more than seven (7). The Doard shall determine the number of Directors to comprise the Board from time to time. Except for Declarant-appointed Directors, Directors must be Members or the parents, children or spouses or shareholders, members, officers or directors of Members. There shall be only one (1) vote for each Director.
- Article X, Section F, is hereby deleted in its entirety and replaced with the following new Section F to read as follows:
 - F. At the Initial Election Meeting, a "staggered" term of office of the Board shall be created as follows:
 - a number equal to fifty percent (50%) of the total number of Directors rounded to the nearest whole number is the number of Directors whose term of office shall be established at two (2) years and the Directors serving for a two (2) year term will be the Directors receiving the most votes at the meeting; and
 - the remaining Directors' terms of office shall be established at one (1) year.

At each Annual Members' Meeting thereafter, as many Directors of the Neighborhood Association shall be elected as there are Directors whose regular term of office expires at such time, and the term of office of the Directors so elected shall be for two (2) years, expiring when their successors are duly elected and qualified.
