This corporation is organized and operated exclusively for:

Charitable, educational, religious, scientific or other purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Big Red Circle, Inc. is organized and shall be operated for purposes within the meaning of Section 501(c)(3) of the Code; provided, however, no part of the net earnings thereof shall inure to the benefit of any private shareholder or individuals; provided further, no substantial part of the activities of Big Red Circle, Inc. shall consist of carrying on propaganda, or otherwise attempting to influence legislation; provided, further, Big Red Circle, Inc. shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, Big Red Circle, Inc. shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by an organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United Statues Internal Revenue law).

Upon dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code), or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
