ARTICLES OF INCORPORATION OF FOUR HEARTS ONE MISSION, INC. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Four Hearts One Mission, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be:
