ARTICLES OF INCORPORATION

OF

FML PARTIAL ROADWAY MAINTENANCE ASSOCIATION, INC., A FLORIDA NOT-FOR-PROFIT CORPORATION,

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation not-for-profit pursuant to the Florida Not For Profit Corporation Act, as particularly set forth in Chapter 617, of the Florida Statutes:

ARTICLE I – NAME

The name of the corporation is:

FML PARTIAL ROADWAY MAINTENANCE ASSOCIATION, INC.

The address of the principal office of the corporation (hereafter called the "Association") shall be 2639 Professional Circle, Suite 101, Naples, Florida 34119 and the mailing address of the Association shall be the same.

ARTICLE II – PURPOSE AND POWERS OF THE ASSOCIATION

The Association may engage in or transfer in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation. The Association does not contemplate pecuniary gain or profit to the members thereof and shall make no distribution of income to its members, directors, or officers. The specific purpose for which the Association is formed is to provide for maintenance the road right-of-way improvements within the Roadway Portion of Musket Lane (as defined in that certain Roadway Maintenance Agreement recorded or to be recorded in the Public Records of Lee County, Florida, referred to hereinafter as the "Agreement", said Agreement being incorporated herein by reference as if set forth in its entirety).

The Association shall have the following powers:

- (a) To exercise all of the common law and statutory powers of a corporation not for profit organized under the laws of the State of Florida, including without limitation as set forth in Section 617.0302, F.S., that are not in conflict with the terms of the Agreement, these Articles, or the Bylaws of the Association.
- (b) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in the Agreement.

- (c) To fix, levy, collect, and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Agreement; to pay all expenses in connection therewith and all other expenses incident to the conduct of the business of the Association, including but not limited to all licenses, taxes or governmental charges levied or imposed against the property of the Association;
- (d) To maintain, repair and operate the property of the Association;
- (e) To purchase insurance upon the property of the Association and insurance for the protection of the Association and its members as Owners;
- (f) To reconstruct improvements after casualty and make further improvements upon the property;
- (g) To establish and enforce by legal means the provisions of the Agreement, and the Articles of Incorporation and Bylaws of the Association, and the rules and regulations adopted pursuant thereto or established from time to time;
- (h) To contract for and employ personnel to perform the services required for proper operation and maintenance of the property dedicated to the Association and any corresponding infrastructure;
- (i) To acquire (by gift, purchase, or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the association.
- (j) To sue and be sued and appear and defend all actions and proceedings in its corporate name.

ARTICLE III – MANNER OF ELECTION OF OFFICERS AND DIRECTORS

The Board shall be elected or appointed pursuant to the terms set forth in the Association's Bylaws and the Agreement, as both may be subsequently amended, supplemented, or restated.
