ARTICLES OF INCORPORATION

ARTICLE I

NAME

1.01 Name

The name of this corporation shall be **Safe to Hope, Inc.** The business of the corporation may be conducted as Safe to Hope, Inc. a.k.a. Safe2Hope or S2H.

ARTICLE II

ADDRESSES OF THE CORPORATION

2.01 Corporate Address

The physical address of the corporation is: 7531 Knoll Drive, Jacksonville, FL 32221

ARTICLE III

PURPOSE

3.01 Purpose

Safe to Hope, Inc. is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. The corporation shall have a racially nondiscriminatory policy as to applicants, members, and others on the basis of race, color, or national or ethnic origin.

Safe to Hope, Inc.'s purpose is to build a community of trust and healing for Child Sexual Abuse Survivors and affected communities.

This will be accomplished through:

Awareness education to Childhood Sexual Abuse (CSA) victims, support people, churches, educational institutions, and community events through

✓ Community enrichment programs

- ✓ Individual victim awareness education
- ✓ Online/social media programming (www.safetohope.com)
- ✓ Classroom training
- ✓ Church and community seminars

And Assistance to CSA victims, support people, churches, educational institutions, and community events by holistically:

Utilizing the following principles and programs to Present Awareness Training to Florida Churches, Child-care Institutions, Schools, Businesses, and Government Agencies to build awareness and support through web based mentoring training and transient presentations as well as a multi-purpose campus:

- ✓ Awareness education and events for community; victim's defining the truth about the abuse (not all victims realize their history falls into the unhealthy category of abuse); train victims and their spouses about healthy strategies to avoid perpetuating secondary abuse and social/community issues through unhealthy parenting and
- ✓ **Neighboring** train volunteers on site or via transient training as force multipliers to care and converse with survivors in their own communities as they share their story
- ✓ Counseling assist with finding and sponsoring affordable and accessible professional treatment as necessary in coordination with their local safe support people and/or transient lodging in a rural "farm stay" retreat to offer an opportunity to break and reset destructive coping cycles so healing can progress.
- ✓ **Hope** teaching the foundational element in the program offered through Biblical teaching about God's character and the plan He has for each victim and survivor
- ✓ Order Create and publish a guided curriculum designed to help the victim or survivor navigate the topics that plague a person with shame and prevent making healthy life choices.
- ✓ Retreats (Farm-Stay) the opportunity of victims or survivors [and family] to focus on healing the hurts of abuse in the safe, nurturing environment of a family-style farm retreat to offer an opportunity to break and reset destructive coping cycles so healing can progress
- ✓ Safety Provide certified CPTED home and facility security assessments, awareness, self-defense, and CSA prevention training to churches, educational institutions, victims and their families.

For the CSA victim individual, community wide, and church wide benefit of

- ✓ Advancement of Biblical teaching in reference to CSA effects on individuals, the church, families, and the community through awareness, healthier members of churches and subsequent communities;
- ✓ Advancement of education through awareness of CSA and avoidance of such abuse, furthering children's mental, physical, spiritual, social, and emotional health;
- ✓ Lessening of the burdens of Government by helping CSA victims Biblically cope with CSA trauma and mentoring to restore healthy relationships and avoid the spiral of increasing government and social dependence when coping mechanisms fail and CSA victims statistically turn to drugs, alcohol, addictions; statistically have higher divorce rates which also increases dependence on welfare, subsidized child care, and leads to criminal activity, and
- ✓ **Promotion of social welfare** by coordinating with other recognized religious and social organizations designed to accomplish any of the above purposes, leading to –
- ✓ Lessening neighborhood tensions through healthier coping abilities and relationships and unneeded law enforcement intervention.
- ✓ **Defending human and civil rights secured by law** in detecting, deterring, and documenting offender behavior, and
- ✓ Combating community deterioration and juvenile delinquency by addressing CSA trauma at earlier ages when statistically only 36% of CSA crimes are reported before 18 years of age and many victims wait until their 30's and 40's to address CSA trauma when coping mechanisms fail. When CSA trauma awareness is addressed at earlier ages, young people are able to avoid juvenile crime and destructive coping mechanisms that fundamentally affects the community.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which will provide opportunities for involvement in said activities and programs in order to have a greater impact for change.

3.02 Public Benefit

Safe to Hope, Inc. is designated as a public benefit corporation.

3.03 Duration

The period of duration of the corporation is perpetual.

ARTICLE IV

MANNER OF ELECTION (APPOINTMENT OF DIRECTORS)

4.01 Manner of Appointment

- (a) All directors shall be elected to serve a one-year term, however the term may be extended until a successor has been elected.
- (b) Director terms shall be staggered so that approximately half the number of directors will end their terms in any given year.
- (c) Directors may serve terms in succession.
- (d) The term of office shall be considered to begin January 1 and end December 31 of the second year in office, unless the term is extended until such time as a successor has been elected.

4.02 Qualifications and Election of Directors

In order to be eligible to serve as a director on the board of directors, the individual must be 18 years of age and an affiliate within affiliate classifications created by the board of directors. Directors may be elected at any board meeting by the majority vote of the existing board of directors. The election of directors to replace those who have fulfilled their term of office shall take place in January of each year.

4.03 Vacancies

The board of directors may fill vacancies due to the expiration of a director's term of office, resignation, death, or removal of a director or may appoint new directors to fill a previously unfilled board position, subject to the maximum number of directors under these Bylaws.

(a) <u>Unexpected Vacancies</u>. Vacancies in the board of directors due to resignation, death, or removal shall be filled by the board for the balance of the term of the director being replaced.

ARTICLE V

BOARD OF DIRECTORS

5.01 Governance

Safe to Hope, Inc. shall be governed by its board of directors.

Any such assets not so disposed of shall be disposed of by the chancery court of the county in which the domicile of the corporation is then located, exclusively for such purposes to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
