

Articles of Incorporation Of

Knight Animal Sanctuary, Inc.

(In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Knight Animal Sanctuary, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 7527 Quail Hollow Blvd, Wesley Chapel, FL 33544. The initial registered agent of the Corporation at such address shall be: Bonnie Barnes.

Article 3.

The name and address of the incorporator is:

Article 4.

Article 5.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purpose of the organization is to care for horses and donkeys, neglected or abandoned.
