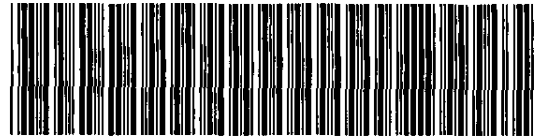

**ARTICLES OF INCORPORATION**  
**FARMWORKER MINISTRY OF MULBERRY, INC.**  
**(Not for Profit Corporation)**

**ARTICLE I**  
**NAME**

The name of the corporation shall be *Farmworker Ministry of Mulberry, Inc.*

**ARTICLE II**  
**PRINCIPAL OFFICE**

The principal office of the corporation shall be 1823 Suzanne Lane, Lakeland, Florida 33813.

**ARTICLE III**  
**PURPOSE**

This corporation is organized exclusively for such nonprofit, charitable and/or educational purposes, and such other purposes *as will qualify the corporation as an exempt organization under section 501(c)(3) of the Internal Revenue Code*, or corresponding section of any future federal tax code. More specifically, the purpose of this corporation is to support, help and improve the lives of low income farmworkers living in Mulberry, Florida. This assistance will include the provision of food, blankets, clothing, children's toys, furniture and direct financial assistance of local farmworkers and their families.

**ARTICLE IV**  
**MANNER OF ELECTION**

The initial directors shall be the Board of Directors of the Farmworker Ministry of Mulberry. Directors shall subsequently be elected *as provided in the Bylaws of the corporation.*





**ARTICLE VIII**  
**NOT FOR PROFIT**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its officers, directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**ARTICLE IX**  
**DISSOLUTION**

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for a public purpose.
