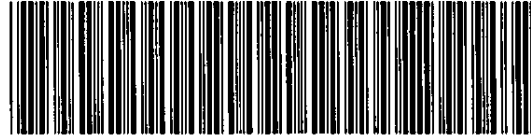

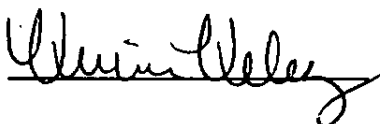
VI. Officers

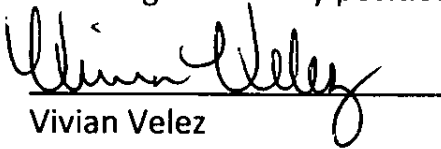
