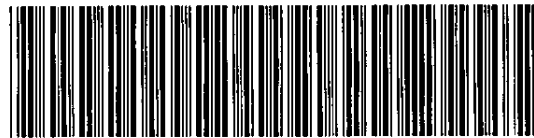

PREAMBLE

The undersigned citizens of the United States, desiring to form a not for profit corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, certify and acknowledge the following:

ARTICLE 1 NAME

The name of the corporation shall be: Christian Training Network, Inc.

ARTICLE 2 EXISTENCE

The corporation shall have perpetual existence.

ARTICLE 3 EFFECTIVE DATE

The effective date of incorporation shall be the date of filing by the Secretary of State.

ARTICLE 4 MEMBERS

The corporation will not have members.

ARTICLE 5 TYPE OF NONPROFIT CORPORATION

The corporation is not for profit, and is a Religious and Public Benefit Corporation.

ARTICLE 6 REGISTERED AGENT

ARTICLE 8 DIRECTORS

The directors will be elected, maintained, and appointed in accordance with the corporation's bylaws. The corporation's initial directors are as follows:

In no event, shall the number of directors be fewer than three.

ARTICLE 9 INDEMNIFICATION

The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

ARTICLE 10 PURPOSE

The purpose of the corporation is exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code and herein stated as follows:

CTN – Christian Training Network, Inc. is a Christ-centered, evangelical parachurch ministry dedicated to making disciples of all age groups for the Lord Jesus Christ through evangelism, teaching and training. CTN – Christian Training Network, Inc. cooperates with churches, schools, individuals and other organizations to provide educational opportunities and to meet spiritual, physical, emotional, and social needs. CTN – Christian Training Network, Inc. also collaborates with educational and training ministries by enabling leadership, equipping educators and providing resources.

The character and essence of the corporation is the same as the purpose.

ARTICLE 11 PROHIBITED ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 10. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE 12 MEETINGS

After incorporation, the appropriate members of the Corporation shall hold an organizational meeting in accordance with Chapter 617, Florida Statutes, as amended. The board of directors of the corporation may participate in a regular or special meeting by, or conduct the meeting through, the use of any means of communication which allows all directors participating to simultaneously hear one another. A director participating in such a meeting is deemed present at the meeting. In the alternative, the board of directors may take actions through signed e-mail communications provided all board members agree.

ARTICLE 13 DISTRIBUTIONS UPON DISSOLUTION

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
