Articles of Incorporation of

DM&A's Me and My CommUnity, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: In partnership with Orange County Public Schools and Valencia College, the program is an opportunity for high-potential girls in their junior year of high school who come from challenging socio-economic environments an opportunity to learn how to work in teams to assess and develop solutions to their community's most pressing problems. This is accomplished with mentoring from the region's most influential female leaders in a three part program: Part 1: in partnership with local healthcare system, the girls are taught the importance of women's health beginning at age 17, Part 2: A full day event is spent working in a group setting on solving a community problem, presenting the solution and being evaluated based upon the creativity, quality and realistic implementation of the proposed solution, and Part 3: a one day internship with a local organization dedicated to the community issue, and Part 4: one to two half day sessions in a custom developed Valencia College higher education prep program which teaches how to apply for college and financial aid, what to expect and how to manage college transition, and overall career planning,

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
