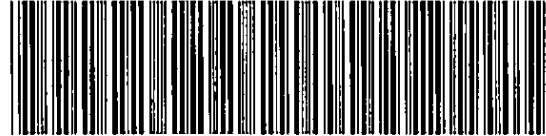

Foxwood Christian Fellowship, Inc is organized exclusively for religious purposes, including, for such purposes, the making of distributions to organizations described under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


