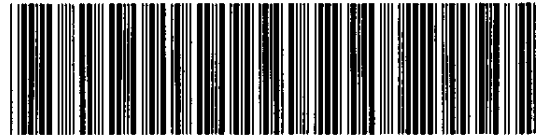

ARTICLES OF INCORPORATION

In compliance with Chapter 617, Florida Statutes, as a Corporation Not-for-Profit

ARTICLE I: NAME

The name of the Corporation shall be Alliance Democrats Inc. (hereinafter, "Corporation").

ARTICLE III: DURATION

The duration of the Corporation shall be perpetual.

ARTICLE IV: PURPOSE

The purpose for which the Corporation is organized is to engage in activities relating to the support or opposition of candidates for public office in the State of Florida and to influence or attempt to influence the selection, nomination, or election of individuals to public office in the State of Florida. The Corporation is organized as a not-for-profit corporation and engages only in activities that are carried on by a corporation exempt from Federal income taxes under section 527 of the Internal Revenue Code, or any successor thereof. No part of the net earnings of the Corporation shall inure to the benefit of any member, except that the Corporation may pay a member reasonable compensation for services rendered.

ARTICLE V: DIRECTORS AND OFFICERS

Directors and Officers of the Corporation shall be appointed as set forth in the Bylaws of the Corporation. In no event shall the number of Directors be fewer than three.
